2019 Annual Report from the Transitional Pastor

This has not been a typical year for BEPC. You lost your beloved pastor of almost eight years. The loss of a pastor under any circumstances can be challenging for a congregation; perhaps retirement after a good run is the least traumatic. It was somewhat unexpected, but Feild didn't "forsake you for another" bigger, higher-paying call; he didn't leave under a cloud of ethical or moral failure. He didn't leave you with a big debt; he didn't leave you divided. He didn't die in office, either, which could bring another kind of trauma. Feild did right by you in every regard. (Running off with a choir member could have been a problem under other circumstances, but he and Laura did that right, too!) One indication that he was an excellent pastor is that you haven't stumbled since he left. Ministry continues as it should; you continue moving forward. Classes are being taught, children and youth are being nurtured, the sick and grieving are being loved, comforters are being sewn, shawls are being knitted, anthems are being sung, bells are being rung, wreaths are being hung (and taken down), the needy are being fed, clothed, and kept warm, bulletins are being run, newsletters are being folded and mailed. The Lees-McRae staff and students were fed to show that you appreciate them. You were even willing to undertake a Christmas Eve dinner for international ski resort employees at Beech Mountain. (A huge tip of the hat to Ed Donnell for picking up the reins before they could hit the ground.)

But what will the future hold? What will the new pastor be like? What gifts will he or she bring? What will be different? What will stay the same? These questions and more are natural and normal. The Mission Study Task Force has been working to find out what your hopes and dreams are for future ministry and what kind of leader you seek to help you do it. The process slowed but is now regaining momentum with a report due next month.

You have also had a transition in the Guatemala partnership with Arca de Noe in Barbara Hosbein's relocation to Ecuador. Her energy and passion for this mission were incredible, her love for the people there genuine, and she cultivated that in you. By God's grace her enthusiasm has transferred to Kathy Ward, who will need all our prayers and support as she grows into the new role.

Since I have been here barely six months, it is a stretch to call this an annual report. The staff and session have been very welcoming and tolerant of me as they learn my quirks and idiosyncrasies. The congregation has been very supportive and encouraging. It is a continuing pleasure to be a part of such a mission-minded congregation. Deb and I have felt the warm embrace of this expression of the Body of Christ from day one and are grateful to be among God's instruments in helping you make the transition to a new chapter of your considerable history. The Apostle Paul's assessment of the church in Philippi is applicable to you: "I am confident of this, that the one who began a good work among you will bring it to completion by the day of Jesus Christ." (Phil. 1:6)

- In December, a letter was sent to all church members notifying each person of the opportunity to send a Love Offering for Rev. Deck Guess. The offering was collected and given to Rev. Guess in Worship Service on December 22.

- Solicit information from the staff to assure their Position Descriptions match the actual duties performed
- Continue to review and revise Position Descriptions and seek staff to respond as the needs of the church evolve
- Conduct annual staff evaluations as directed by Session
- Work with Session on budgetary issues regarding Personnel
- Report to Session as needed
- Continue to refine and assess duties and responsibilities of staff to ensure efficiency and equitable workload distribution

Mission Committee Annual Report 2019

Because of a very generous budget, the Mission Committee was able to increase its support for many of our traditional missions as well as adding a few new ones. RAM, Avery County Habitat, Yellow Mountain Enterprises, Feeding Avery Families. Scottie, The Hill School, and Time for a Change, to name but a few of our local missions. Internationally we supported the Causby China Mission, the Guatemala project, The building Hope Campaign, and the PCUSA Water Purification fund.

Our Mission Discretionary Fund enabled us to respond quickly to several needs. We provided scholarship assistance to a Lees-McRae Student. Because of rising prices, we provided additional funding to Time for a Change for additional diapers and formula. Lastly, because of an unusually harsh and early winter, we gave additional funding to RAM to provide money to assist their clients with heating bills.

Mission Committee: Rob Clemmer Benevolence Fund Report 2019

One of the many positions Rob Clemmer filled during his years in the church office was to talk with individuals requesting assistance from the church, and to then research the validity of the request. When Rob moved from this area funds were given to the assistance fund in his honor, Session chose to use the ongoing name for the mission objective, the Rob Clemmer Benevolence Fund. A committee was recruited to serve on this weekly mission objective with members Tony Fortune, E. C. Newman, Carolyn Jones, Donna Dicks, El Wilson, Murry Haber, Rocky Holscher, and Susan Carter. Policy and procedures were developed.

Most of the requests to the REBF are for preventing the power disconnect, or for home heating oil. Other situations include a newly divorced mother with overdue mortgage, unexpected car repairs, behind in rent payments, dad injured at work and has four small children, etc. When a request comes to the church a form is used to complete the details, and a committee member verifies the situation with the power company, landlord, etc. The committee has responded to 51 Requests for Assistance, with only a few of the requests coming from repeat individuals. Records total nearly \$9,000.00 provided to meet the call-in crisis requests.

Worship Committee Annual Report 2019

Purpose: To provide meaningful worship experiences for our congregation using new and familiar modalities while preserving our reformed tradition. To work closely with the pastor, volunteers, and sub-committees in providing suggestions and oversight of the worship areas in the life of the church in order to help the congregation experience true worship.

Accomplishments in 2019:

- All sub-committees continued to function well: Communion Set-Up; Flowers; Funeral/Memorial Services; Kirkin' O' The Tartan; Ushers; Acolytes; Wedding Committee; and Worship Arts Committee, with a new "Banner" sub-committee.
- Worship Arts continues to play an important role in the life of Banner Elk Presbyterian. See attached.
- Serving Communion by Intinction was once again approved for winter months (November through April) with the exception of the 5:00 p.m. Christmas Eve service at which time communion was served by passing the trays.
- Ash Wednesday Palm Sunday, Maundy Thursday, Good Friday, and Easter services were held on March 6. April 18, April 19 and April 21, respectively.
- Our annual Sunday morning Worship services at 8:30 a.m. were held June through September along with our regular 11:00 a.m. services.
- We were blessed with another year of uplifting music presented by the Choirs under the direction of Diane Rydell. See Attached.
- Kirkin' O' the Tartan was held on Sunday, June 30.
- Punch on the Lawn was enjoyed throughout the summer months.
- Gratitude and well wishes were given to Rev. Feild and Mrs. Laura Russell as we said goodbye when Rev. Russell decided to take early retirement beginning in mid-July.
- In August we celebrated the arrival of Rev. Deck and Mrs. Deb Guess. We are delighted to have Rev. Guess as our Transitional Minister, and are thankful for his and Deb's presence.
- We are most appreciative of our Rev. Dr. Ed Donnell who supplied during part of July and August between the leaving of Rev. Russell and the arrival of Rev. Guess. Also during the year, we were pleased to have Rev. Tom Phillips, Rev. Bobbi White, and Rev. Maggie Lauterer fill in.
- BEPC participated in two community services: Easter and Thanksgiving.
- We continued our involvement with Mayland Presbyterian Fellowship.
- Our Hanging of the Greens and Chili and Cornbread Luncheon was held on Saturday, November 30, with church wide participation. (Also, Bob Pullease made and gave us his "annual" wooden Chrismon for which we are most appreciative.)

Music Ministry Annual Report 2019

We continue to have 2 vocal and a handbell choir in 2019; the mixed choir, which sings each Sunday during the 11am worship service; the men's choir at the seasonal 8:30 am worship, and the handbell choir, which plays several times a year at 11am worship. While each is unique in people, there are a few who participate in 2 of the choirs.

The mixed choir lost several members this year due to moves, retirement and health concerns but we have added several and a new scholarship program to include Lees McRae students when school is in session was begun. We also purchased new "Sunday" folders for the choir so they all match. For the third year the mixed choir sang with the "Holy Cross" choir in late May as the first part of their Summer Concert Series held at St. John's Chapel, which was an enjoyable venture.

The men's choir is smaller than in previous years mainly due to health issues of the men (or family members) but the group is very enthusiastic and loyal.

Handbells also has several who have had health concerns, but we also have members from other churches participating in the group. We are continually striving to improve and look forward to a workshop in late August by the Raleigh Ringers, who will perform at Lees McRae. We were able to contribute to the cost of the workshop by the Raleigh Ringers through the generosity of those who contribute to a "music committed fund" each year.

Walking with Shadows Annual report 2019

Walking in Shadows is designed to support the caregiver (or person affected) who deals with persons with mental illness. They continue to meet on the second Monday of each month with attendance of one to six people. The sessions are designed to help caregivers and friends of those with Depression, Anxiety and Bi-Polar Disorders and is entitled *Walking with Shadows*. Christian Education Committee Annual Report 2019

The CE Committee has maintained and extended programs for the congregation this year. The education programs that have continued this year include: The Faith Seekers class for adults on Sunday morning, a class for Junior High and Senior High students on Sunday morning(now twice a month), a class for children ages 3-7 on Sunday mornings.

Preschool Annual Report 2019

The Preschool operates with a Board consisting of the Preschool Director, Pastor, with church, community, and parent members following a Session approved Policies and Procedures Manual. In August, the Board added a Church Finance Officer position. The program serves children ages 2-5, operates 91/2 months following an August-June school year calendar, Monday-Thursday, 9:00am-1:00pm.

In January, the middle of the Preschool year, 28 students were enrolled. Staff employed were A.C. Marriott, Director/3's Lead Teacher, Teacher; Tiffany Ledford, Assistant Director/2's Lead Teacher; Kerri Ledford, 4's Lead Teacher; Lucy Corning, 3's Teaching Assistant; Marti Dodd, 2's Teaching Assistant. In August, the beginning of the Preschool year, 24 students were enrolled staffed by AC Marriott, Director/3's Lead Teacher, Teachers; Martie Dodd, 2's Teacher; Britt Ammann, 2's Teacher Kerri Ledford, 4's Lead Teacher; Lucy Corning, 3's Teaching Assistant. The year ended with a continuing Staff and 26 students enrolled for January.

The children have Chapel scheduled every Thursday, a visiting Story Reader twice a month, dance/drama class twice a month and special music program twice a month. Fundraising events included Puppets, Pancakes, and Pajamas Family Book Fair, Movie Night, Parent's Night Out, Friday school and Woolly Worm Parking, hot chocolate stand and Lemonade stand. The SonShine Playground has provided active joyful outdoor play each day the weather permits. Letterland literacy and STEAM inspired curriculum is implemented for the three classrooms. Also, the 4-year old class visits "Letterland at Tweetsie Railroad" once each year. As a group the children participate in 11:00am Worship by singing in in May and December. The Summer Camp weeks are reported to be joyful theme based learning experiences, and the Camp is meeting a need for quality summer preschool child care.

The evacuation plan continues with documented Fire Drills, with the November 2019 drill completed in 2 minutes and 30 seconds. Preschool Staff members participated in a Blue Ridge Partnership for Children sponsored CPR/First Aid training and are encouraged to take training classes online and attend any BRPC sponsored in house trainings.

Three teachers attended the Georgia Early Childhood Conference with very positive feedback regarding the quality of the workshops offered. (Katie Fletcher was formerly President of the Georgia Preschool Association)

The Board developed and received gifts for the three classrooms from The Giving Tree. Contact A.C. Marriott to arrange a time to come see how these are being enjoyed by the children. Thank you to the generous contributors.

The Wedding Committee Fund transferred \$675.00 to the Preschool Scholarship Fund. The Board approved 7 Scholarship for January-June and 6 Scholarships for August-December.

Stewardship and Finance Committee Annual Report 2019

The Stewardship and Finance Committee is responsible for overseeing the financial matters of the church, for coordinating the work of the financial staff and the treasurer with the Session, and for conducting the annual stewardship campaign.

The committee met monthly, with a few exceptions, throughout 2019 and monitored the monthly financial statements of the church as well as dealt with various matters that arose during the year.

The year began with our work on transferring funds to pay off the outstanding loans the church had taken out to finance the purchase of property on which on parking lot is situated and the development of that parking lot as well as the new playground. Through prudent stewardship of our funds we were able to completely pay off these loans and to proudly declare that our church is now entirely debt free.

This year for the first time in many years we commissioned an audit of our financial records by an outside account. Sharon Gillespie of the CPA firm of Young Miller & Gillespie PA conducted the audit in May and certified the accuracy of our records, giving us all the comfort of knowing that our finances are being maintained accurately.

Among other things, the committee reported the sale of the four lots on Beech Mountain that the church has owned for some time was completed and the proceeds added to the committed funds of the church.

We also explored new methods of giving to the church though electronic funds transfers and the church website. This year a very successful stewardship campaign was conducted under the leadership of Chuck Dickinson. The theme of the campaign was Vision 2020, and under Church leadership, we helped the congregation understand the financial needs of the church and the spiritual need for all of us to give back some of what God has given us to us. The campaign included weekly Moments for Stewardship delivered at services throughout July and August, each of which highlighted one of the many missions of the church, several special mailings, articles in the monthly newsletter and other communications to the congregation. By the end of the campaign, 115 pledges were received, totaling \$358,285. A sincere and heartfelt thank you goes out to all of you in the congregation who helped us achieve these results.

The stewardship within this church not end with our annual campaign, as many in our congregation are regular contributors to our annual fund even though they choose not to pledge, and many others contribute to the many special causes and missions that the church promotes. All totaled over 20% of the money raised by the church goes to mission.

Finally, we prepared a balanced budget for 2020 which was approved by Session and which allows us to proceed with the missions and ministries of the church along with the necessary expenses that allows us to continue operating the church on a stable basis.

Special thanks for successfully completing the work of the committee goes to our treasurer Dorothy Pullease, and our treasurer-emeritus Ron McGowan. Many thanks also to the other members of our committee, Bill Ferguson, Bruce Pendergast, Jeff Davis, Phil Craig, and to ex officio members Alisa Ballard, Rev. Feild Russell and Rev. Deck Guess. And finally, thanks goes to Dedy Traver who provided our monthly statements and answered questions no one else could.
