

Pastor's Annual Report 2021

This was another year in which the Holy Spirit fueled our ingenuity and imagination in ministry. It was also a year of transition and new beginnings. 2021 began with worship being conducted online via YouTube due to the continuation of the COVID-19 Pandemic. The Lenten season was a hybrid of in-person and virtual gatherings as well. Church members used their gifts and talents to share with one another their faith and reflections through video devotionals by individuals, a special video highlighting the caring ministry of the Comfort Makers, as well as beautiful musical reflections During this important season of the life of the church, Christian Education leaders and Congregational Care members helped people stay connected with their siblings in Christ whether they felt comfortable gathering in-person or remaining home. Pastoral Care continued to be a challenge as the pandemic waned and surged throughout 2021 making hospital visits and homebound visits difficult to impossible depending on the surge. I look forward to connecting with those of you I have not met, and I am grateful for the Shepherd ministry that keeps us in care and in prayer for one another. Devotions for Children were recorded by many members of the congregation so that even the youngest members of our congregation could feel loved and supported by their church family when many were still staying home due to the Pandemic.

As summer approached everyone was happy to greet and welcome back the beloved "summer people" as worship continued in-person throughout the summer. The beloved Kirkin' O the Tartan was a luminous tradition that was able to continue this year! The summer ushered in a new season for Banner Elk Presbyterian Church. On July 18th the Pastor Nominating Committee called a Congregational Meeting to announce their recommendation for the new pastor. The Pastor Nominating Committee's diligent and faithful task had been completed, as they called, well...me! July 18th was a special day for our family, not only because it was Isaac's 15th birthday, but because we were delighted and incredibly blessed that God called us here to Banner Elk Presbyterian Church. There are no proper words to explain the honor it is to be called to serve here as pastor, as the first woman Head of Staff, and to be ordained in the ministry here in such a place with such a rich history of Christ-led service to the community. On behalf of the congregation, I would like to extend gratitude for the tireless and pray-fueled efforts of the Pastor Nominating Committee.

Our community gave a beautiful farewell to Rev. Deck Guess on August 29th. We are so grateful for his transitional ministry, which turned out to be so much more than that. He not only led the community through a time of pastoral transition, but through a pandemic. His service, care, worship, and friendship during this unprecedented season will indeed be remembered. A beautiful table was given in thanks and gratitude to Rev. Deck and Deb. The table, a true work of art, was created by Dr. Dick Larson and presented by Dr. Jim Ferguson. On behalf my colleague in ministry, Rev. Deck sends his greetings, prayers, and love to you all this very day.

On August 26th, in-person choir practice began again, under the leadership of another new member of the Banner Elk Presbyterian family: Nina Allbert. The worship life of Banner Elk Presbyterian was beginning anew with a new pastor, a new choir director. Thanks to the media team and the session for the continued effort to provide on-line videos of worship services to those who were not able to join us for in-person worship.

October 10th marked a day of two Sunday services, morning worship, and my Ordination Service. I am so grateful to Rev. Dr. Byron Wade, the General Presbyter of the Presbytery of Western North Carolina for preaching my ordination sermon. I am thankful for my fellow ministers Rev. Maggie Lauterer, Rev. Kathy Campbell, and Rev. Tee Gatewood for serving in leadership during the service as well.

Although the pandemic shaped our worship through the end of 2021, with the help of our amazing Worship team (Music, Communion, Media, Arts) we were able to create a truly beautiful Advent season with a blend of new and old traditions. We began the Advent season with a baptism! What pure holy joy to baptize Isaiah Bender into the family of Christ! We were honored to host the Community Carol Sing and usher in the light of Christ through music. I am also grateful to all of those who wrote for our Advent Devotional which brought Scripture and Meditation to the in-boxes of our community each morning of Advent. Many thanks to the

Communications Committee who created a new logo, Christmas Cards for our members and extended church family, and invitations mailed to friends of BEPC to join us for our Advent events. We all continue to take a posture of openness and flexibility in how we can best connect with one another and the community-at-large, whether that is invitation to join us for in-person events or continuing to invest and explore in digital connections for worship.

When I look back upon 2021 all I can see is light. The light of Christ shining through the darkness of the pandemic, the new day that God brought to Banner Elk, and the continued commitment by the congregation to make sure that no one in Avery County and beyond felt left alone, hungry, or unloved. It was another year of the generosity of our Lord being poured out onto us and going forth into the community. Prayers were lifted, meals were shared, gifts of time, talent, and blessing were given. I have faith that the light and connections with one another will grow even brighter as we continue to live out our faith in this new season in which God has led us and walks beside us.

Purpose and Responsibilities:

- 4. Facilitated by Janet Speer, employed David Soyars Organist/Pianist, Nina Allbert Choir Director, Suzie Fisk, Hand Bell Director.
- 5. Conducted evaluations of staff members using evaluation forms developed by the Personnel Committee.
- 6. Maintained Nursery Caregiver position.
- 7. Maintained Personnel files in the locked fireproof box in the church office.
- 8. Reinstated the LMC Choir Scholarship Program under the direction of Nina Allbert.
- 9. A December bonus was given to each staff member as planned in the 2021 Budget.
- 10. In December, a letter was sent to all church members informing them of the opportunity to send a Love Offering for Rev. Rachael McConnell. The offering was collected and presented to Rev. McConnell at the close of the Congregational Meeting on December 19.

Goals and Objectives for 2023:

- Solicit information from the staff to assure their Position Descriptions match the actual duties performed.
- Continue to review and revise Position Descriptions and seek staff to respond as the needs of the church evolve.
- Conduct annual staff evaluations as directed by Session.
- Work with Session on budgetary issues regarding Personnel.
- Report to Session as needed.
- Continue to refine and assess duties and responsibilities of staff to ensure efficiency and equitable workload distribution.

Specific reports on music from directors

Choral music by Nina Albert

I started working with the BEP music ministry in September. We began the fall with a choir of 25. We have prepared music for Sunday services, an ordination, a community carol sing, a candlelight community service at Mt. Calvary Baptist church, a lesson in carol service, a children's pageant, and two Christmas Eve services. I am delighted that we have a nice blend of returning long time choir members and new members. Of course our numbers go up and down based on the season. We are so fortunate to have other fabulous musicians to add to our service music. First and foremost our wonderful pianist/organist David Soyars. But also, we have 2 flautist, a pianist, a handbell soloist, the handbells choir, and a saxophonist! We started the year singing with shields, after consulting with our medical professionals it was decided that for the safety of the choir, with the omicron variant we should move to using singing masks. Hopefully, one day these will no longer be necessary. We are moving forward, the choir is growing stronger vocally, we are adding new members, and most importantly, the choir seems to be enjoying our varied repertoire and singing praises to God.

Handbells by Suzie Fisk

The Handbell Choir moved to a new practice room.

The bells were refurbished by Blake Long of CBL Handbell Services. He came to the church to do the work in July.

The choir members learned many new skills including the ability to make any necessary repairs to the bells.

The acoustics in the sanctuary were explored by ringing from different areas besides the typical front spot; most notably the balcony.

The church invested in modest attire which makes the group look fully coordinated.

The handbell choir played seven times including three times during Advent.

Keyboards/music direction-David Soyars (also did Men's Chorus in 2021)

It has been a pleasure to create worship music with our many talented musicians since coming on board as interim organist in May and transitioning into the on-going role of organist/pianist. We successfully programmed a wide variety of special music throughout the summer months in addition to the men's ensemble. Special thanks to Janet for her assistance. Nina has been a joy to collaborate with and her energy and skills have certainly created a renaissance in the choir.

The piano and organ received their spring and fall tuning and maintenance which is recognized as standard for most church instruments. Both service providers were changed to ensure we have highly competent and dependable technicians. The piano technician provided needed improvements to the action of the piano, making it significantly more responsive with an end result of much improved sound and dynamics. He will continue with some adjustments at the spring tuning, being mindful of our budget.

The organ required additional maintenance last spring to address several problems.

The organ tuners have advised that we probably should plan to replace the tuning sleeves in the next year or so. The tuning sleeve is a ring of metal at the top of each pipe that slides up or down incrementally for tuning. Age and normal wear cause them to slip too easily which can make it difficult to tune the organ, as well as have some notes go out of tune more quickly. This just needs to be on our radar for planning. They also inspected facade pipes and made upfitting recommendations for safety after a pipe fell in December. Repairs are anticipated in early 2022. Given the age of the organ, it also seems advisable that we should anticipate some larger repair expenses in the coming years.

Fellowship Committee Annual Report 2021

Accomplishments of this committee, normally in charge of providing meals for the congregation, usually monthly, were somewhat curtailed by restrictions involving Covid 19. However, two Second Sunday brunches were held in the King Fellowship Hall, along with a June 13 Lunch on the Lawn, catered by Subway. This was a collaborative effort with Congregational Care.

The Care Call Connection, also a collaborative effort with Congregational Care, began in March and continued throughout the year with at least 26 volunteers calling members of the congregation on a regular basis.

The annual picnic was held on July 22, at Tate/Evans Pavilion. This event served as a "going away" and "thank you" for Reverend Deck Guess. Daniel Boone Inn catered the event.

The reception following the ordination of Reverend Rachael McConnell, on October 10, was sponsored by the Fellowship Committee, with the assistance of Don Hilsmier, Membership.

Waffles for Toys took the place of the Second Sunday Brunch on November 14. Joining with A.C. Marriott and volunteers from our youth and their parents, attendees brought unwrapped gifts to support Avery Project Christmas Store.

The maintenance and care of the kitchen is monitored by Chris Zimmer, who keeps supplies stocked.

Many volunteers willingly serve this committee and are on hand to set up and dismantle tables and chairs, run errands, deliver food, secure facilities and in general, always step up to serve.

Goals for next year will be pared down due to budget concerns. Catered meals will be discontinued, and we will rely on pot-luck meals from many talented cooks in our congregation. We are hoping to revise Second Sunday Brunches/Breakfasts when the concerns for open gatherings are lifted.

Congregational Care Committee Annual Report 2021

This past year has been continuing challenges for our worship as a congregation due to the Pandemic. Nevertheless, we have soldiered on with the Holy Spirit leading our way. We have several Care committees that have managed to function without compromise to its receivers. Below are subcommittee reports.

Prayer Committee Report

The Prayer committee ministry sent out 288 church member letters twice during the year. They sent five letters to five families a week and focused prayer on these five families. Private prayer requests came to us, and they were added each week. The families often reached back out to our team with special requests.

This past year and year before we created calling teams with people from Nurture and our group. We were to call twice a year or more. to "check" on members and how they were handling quarantines, vaccinations, deaths, illness, generally a whole new way of life for all of us. Loss of jobs, social distancing, and families could not be together. In the Spring, we had an outside lunch at church that was catered. And it was a breath of fresh Spring air, enjoyed by many members. It gave a boost to carry on with innovative ideas for congregating.

Stephen Ministry Report

Note: With Covid, in person events were challenge

Care receiver #1 outstanding results. Worked with a Stephen Minister about three months and was comfortable to cease sessions for three months.

Care receiver #2 good results for getting some tools and working for four months, and then the receiver wanted to end sessions, yet wanted the Stephen Minister to be available as needed.

Care receiver #3 was not formalized and Care giver called once a week for a session and keeps a strong email connection.

There have been one or two more receivers for one or two events and have not been formalized or documented. The call campaign extended to the Stephen ministry and their clients. The ministry reached out to their receivers to see if there were any discussion regarding our new lifestyle through the Pandemic days. If the clients wanted to be called more, then the ministers would check on their wellbeing. This time has been stressful on all ages and depression has been rampart.

Walking with Shadows Report

This is now a part of the Stephen Ministry and has a Stephen Minister as a facilitator. Meetings were not a possibility because of the Pandemic and quarantine. We are on pause now but will continue later. Some meetings were on zoom, with an educational film and then discussion with the group. We lost a minister due to a move and now have a male and female minister. We will pause until we receive more requests, we will be on standby.

The Prayer Shawl Ministry has met in various forms this past year with the knitters and crocheters meeting outside on the lawn, by Zoom, and socially distanced in the Margaret Tate Parlor and the Fellowship Hall. Approximately 40 knitted and crocheted shawls were completed this year with 25 shawls being shared with church members, families, and friends across the globe. The Prayer Shawl Ministry is budgeted as a Subcommittee of the Missions Committee. Most of the yarn is donated leaving Budget expenses to purchase some yarn, postage, card stock, envelopes, gift bags and tissue, and shawl labels.

Programs and activities carried out this year include:

- various Zoom studies including Lent and Advent studies (number in group):
 <u>Practicing: Changing Yourself to Change the World</u>: Escobar (8-10)
 <u>Lent of Liberation: Confronting the Legacy of American Slavery:</u> Mills (15-20)

 Advent in Plain Sight: Duffield (8-12)
- in-person women's 9-week summer study using PW Horizons session on "Lament" (12)
- "Lent at Home in Community", a six-week program for our families with children to complete at home. Materials distributed to 12 families.
- 12 weeks of children's devotionals led by various members using the <u>Children's Story Bible</u> (a copy given to each family to keep); links posted for families to view at their convenience (4-5 families).
- Several high school students served as leaders for the S.A.V.E. program (School-Aged Virtual Education), to support our church and preschool families which had children in elementary school, during COVID breaks from school.
- Faith Seekers adult Sunday School class met using Zoom and in-person settings during the year; Steve Bender, Janet Speer and Martha Williams led various studies
- VBS was held July 27-29 for 4-11 year-olds from 5:30-7:30 with the Children's Study Bible as basis for lessons. Volunteers from congregation assisting in teaching and helping. Well received with 15 children in attendance.
- Stuffed toys VBS held for one week in early September organized by AC Marriott who posted photos on the church website.
- Blessing of the backpacks during worship to blessing our children and youth as they prepared for a new school year; each given a token to remember God's care and love.
- Children's music class and Sunday School began in September, led by Nina Allbert and volunteer teachers; 9:30-10:30 each Sunday outdoors, weather permitting, in fellowship hall when needed (4-7)
- Children & Youth Christmas Pageant during worship on Dec. 12th.

Possible goals for 2022:

- Create more opportunities for adults to gather/learn/share
 Short-term special topics or studies with outside speakers
 Dinner and study groups for several weeks in summer
 One-day seminar (s) with lunch and special speaker/topics
- Build up our youth program perhaps by joining with other churches for regular events; concentrate on service-oriented activities
- Enable youth to attend camp experience at Montreat
- Possible family retreat in fall
- Continue to support and expand our children's programs

Preschool Annual Report 2021

The Preschool operates with a Board consisting of the Preschool Director, Pastor, Church Finance Officer, with church, community, and parent members following a Session approved Policies and Procedures Manual. The program serves children ages 2-5, operates 91/2 months following an August-June school year calendar, Monday-Friday, 9:00am-1:00pm. Summer Camp is offered.

In January, the middle of the Preschool year, 22 students were enrolled. Staff employed were AC Marriott, Director/3's Lead Teacher, Teacher; Martie Dodd, 2's Lead Teacher; Jarrett Koski, 4's Lead Teacher; Lucy Corning, 3's Teaching Assistant; Britt Ammann, 2's Teaching Assistant.

In August, the beginning of the Preschool year, 25 students were enrolled with all previous school year staff returning! After budget considerations the board voted to give all staff a \$1.00/hour raise for their continuous hard work. Tuition was raised to \$300.00 per month. At the beginning of August, \$7,200.00 out of a \$10,000.00 donation was spent on new child size lunchroom furniture, new classroom supplies and educational materials.

Despite COVID concerns, the strictly enforced COVID Policy was successful in keeping the Preschool open. Also, the Preschool Board adopted the October 1, 2021 BEPC COVID-19 Policy & Guidelines, and four out of five staff members are vaccinated with the fifth one going to get tested weekly. The board decided to test out our drug abuse policy and initiated a testing program done unannounced and all staff members tested negative.

The 8 weeks of Summer Camp had a full enrollment of 12 students each week. The Summer Camp weeks are reported to be joyful theme-based learning experiences, and the Camp is meeting a need for quality summer preschool childcare. The theme for 2021 summer camp was "Pete The Cat".

The partnership with Holston Camp Preschool for coordinated afternoon childcare did not proceed as anticipated.

Parents, staff, and board members coordinated a "donation" parking arrangement during Woolly Worm weekend. After splitting the money with the youth activities account, the Preschool earned \$603.00.

The children have Chapel scheduled every Thursday. Due to COVID-19 extracurricular activities such as story readers and music class have been put on hold to limit outside exposure. The Son-Shine Playground has provided active joyful outdoor play each day the weather permits. Letterland literacy and STEAM (Science, Technology, Engineering, Arts, Mathematics) inspired curriculum is implemented for the three classrooms.

A group of wonderful students from Lee's McRae College helped the preschool one day for LMC Mountain Day of Service in October. New child sized lunchroom furniture was put together and the SONshine playground was cleaned up with leaves raked, new mulch spread, shed organized and toys upkept. We are very thankful for the close relationship to LMC.

As a group, the children participate in 11:00am Worship by singing in in May and December. Rather than in person worship in December the preschool children recorded a singing performance that was sent out to all preschool parents, posted on church and preschool Facebook page.

The evacuation plan continues with documented Fire Drills, with the December 2021 drill completed in 1 minutes and 52 seconds. Preschool Staff members are encouraged to take training classes online and attend any Blue Ridge Partnership for Children sponsored in house trainings. Director attends quarterly director meetings.

All five teachers successfully attended the Georgia Early Childhood Conference by Zoom in early March, with very positive feedback regarding the quality of the workshops offered. Three staff members also attended 3

hours continued education workshop via zoom on a Saturday in September. We hope to make this a yearly continued educational opportunity. (Katie Fletcher was formerly President of the Georgia Preschool Association).

Continuing from the Fall Session 2020, as a mission of the church in response to coronavirus pandemic restrictions, with scholarship support from Session, the Preschool Board and Staff operated a School Age Virtual Education (SAVE) program. This was developed to meet the needs of elementary school age children whose parents are teaching at BEPC Preschool, are members of BEPC or are members of the community who need a space and an adult assisting with an affordable cost education. In January, 14 students continued enrollment. With elementary age students returning to in person learning in April, SAVE was discontinued.

We hosted a successful five-day Scholastic Book Fair in April. Social event such as pancake supper was put on hold this year due to COVID-19 concerns. We earned \$743.00 in scholastic dollars as a profit which is used for new supplies and materials for the upcoming preschool year.

After receiving a request from a family in need for Christmas, our preschool board adopted an "Angel Tree Family" consisting of a single parent with five children. The two Parent Representatives to the Board took charge and collected gifts from our community to help the family to a wonderful holiday. The need was well received and completed with success.

From the benefit of two non-member weddings in 2021, \$1,000.00 was transferred to the Preschool Scholarship Fund. Families receive partial monthly funding with the Spring total approved at \$355.00 per month and the Fall total approved at \$720.00.

Building & Grounds Committee Annual Report 2021

Building and Grounds had no large facility needs this year and fortunately was able to support an upgrade in landscaping, computers, equipment purchases to improve the live streaming, and updated wired and wireless networks and telephone system. These costs included an increase in landscaping and mowing to \$10,000, computers for Rev McConnel (\$2800) and A.C. Marriott (\$500), sound and camera system equipment for live streaming (\$900), and AV consulting and improvements (\$1600). These improvements follow expenditures of almost \$1600 In 2020 for AV equipment to support live streaming.

We also expanded the B&G Committee by adding 3 new members, a 2nd session member, and the landscaping coordinator. Our committee grew from 2 to 7.

Below is the more detailed report from Larry Zimmer, BEPC Clerk of the Works.

BEPC Clerk of the Works Report - 2021

Major Projects:

- Update wired and wireless network throughout the facility to improve reliability, speed and security. (William Dethlefs)
- Update telephone system to VOIP (Voice over IP) for additional flexibility and features. (William Dethlefs)
- Developed and implemented "in-sanctuary" live stream and video recording capability (in collaboration with Mark File)

Ongoing Maintenance:

- Replace lights and ballasts as needed.
- Minor plumbing repairs e.g. drips, running toilets, clogs, etc.
- Minor repairs e.g. broken tables, ice maker, spot clean carpets, etc.

Other Projects:

- Replaced timers for outside lights to automatically adjust for nighttime hours and include battery backup.
- Installed wiring for narthex table lamps.
- Enabled remote access to church files for authorized personnel.
- Moved Handbells across the hall on 2nd floor and replaced lights with LEDs.
- Trapped / removed ground hogs and blocked entrances. (Alisa / Ron Gore).
- Removed Little Lending Library.
- Replaced broken handrails at choir entrance and added reinforcing brackets.
- Tested illuminating stained glass windows in belfry. Discontinued due to limited benefit.
- Added surveillance camera to main hallway facing elevator.
- Replaced missing mirror panes in window in 2nd Floor Ladies Room.
- Eliminate drip from roof over choir door deck.
- Adjusted and lubricated Sanctuary entrance doors to decrease sticking and ease locking.
